- Meeting called to order at 4:08 PM.
- Treasurer: After previously acknowledging the resignation of Kirsteen Anderson as Treasurer, per her email correspondence dated 06/07/2022, officers met on 06/09/2022 and recognized the need to fill the vacant seat. After collecting nominations from the neighborhood listserv, AL self-nominated and the remaining officers needed to vote on the appointment to the officer role of Treasurer. MG, CS, BE all aye vote, no nay votes. Andrew Laurenzi seated as Treasurer for CGNE Neighborhood Association. Officers discussed the merits of being able to accept membership dues by check and Zelle as a digital form of payment instead of PayPal or other services that may have percentages of the money taken to rendering the service. AL to investigate. BE and AL to take appropriate paperwork to sign AL onto the CGNE accounts at Chase Bank.
- Next Neighborhood Meeting: Rough idea is to meet every other month and invite the whole neighborhood to attend. Plan on meeting for our next meeting in September as a whole neighborhood. Official date set for 09/10/2022 at 9AM located at Conner Park.
- Grant Rd Coalition: BE noted that there has been correspondence from adjoining neighborhood associations that form the Grant Rd Coalition. Former president Brian Silverstein has represented CGNE is coalition representation, BE to take lead on representing and communicating CGNE needs going forward, unless another neighborhood representative comes forward to fill that role. BE said he can pass along relevant Grant Rd Phase 5&6 Plans for our officers to review, need for neighborhood to weigh in on priorities (i.e. green space).
- Newsletter: Victoria Mills working on a Welcome Packet for new residents who have moved into CGNE, officers contact information will be updated. This information will also be included in the paper mailing of the newsletter.
- Speed Bumps: BE noted that his wife Chelsea Blue has submitted a request to DTM to fill out a petition for multiple speed bumps to be installed along Wilson Ave between Copper St and Glenn St. 60% of adjoining property owners or renters need to sign to approve the installation of speed bumps or any other speed mitigation techniques through the Neighborhood Traffic Management Program. Speed trailers will be set on both side of the streets to collect data on speeds and traffic counts along Wilson.
